Banks (Bonnie Stewart) - The Banks Committee is having a public hearing on Thursday where they have a number of different issues on the agenda regarding identity theft and investment in public securities. They are no other banking matters of interest to the business community at large at the moment.

Commerce (Louis Bach)– At last week's public hearing CBIA testified in support of a modified **SB-842**, the Jobs Impact Statement bill, asking that the legislature consider the relative complexity of data that informs employment modeling and the need for knowledgeable and experienced staff to perform the analysis. It was highlighted that the most accurate economic modeling can, for example, identify the results of capital investment and show the increase in state employment resulting from the manufacturing job "multiplier effect." More nuanced data, however – the state's overall competitiveness – is not as easily discerned through even the most careful economic modeling. Job retention and increased skill levels among current employees are more difficult to account for, though they are no less important to a complete understanding of the overall employment picture in Connecticut.

The Commerce Committee is going to be fairly quiet this week, holding an informal presentation tomorrow.

Labor (Kia Murrell) – Due to several snow storm cancellations, the Labor Committee is very busy this week.

SB-913 An Act Mandating Employers to Provide Paid Sick Leave to Employees has finally been drafted and raised. The bill is essentially the same as in past years, applying to employers of 50 or more employees, and exempting only day or temporary workers and certain state university system employees. The Committee's public hearing deadline of Feb 22nd makes it likely that a hearing will be scheduled very soon.

On Tuesday the Committee will hold an informational forum on Binding Arbitration and Prevailing Wage.

On Thursday the Committee will hold its first public hearing. **HB-5460** An Act Concerning Captive Audience meetings is on the agenda. That same day, an informational forum on Unemployment Compensation will also be held.

The Public Safety, Veterans' Affairs and Housing Committees are also holding public hearings this week but there are no business issues on the agendas.

- **HB-6200** An Act Concerning The Imposition Of Tolls On New Highways Or Highway Extensions
- **SB-31** An Act Requiring The Operation Of Gateway Tolls

We are also following a few bills regarding special transportation funding:

- **SB-699** An Act Concerning The Use Of Funds From The Special Transportation Fund
- **SB-773** An Act Concerning The Voting Requirement For Nontransportation Appropriations From The Special Transportation Fund

We also expect the Governor and the legislature to advance a measure creating an independent authority to run Bradley Airport. We are supportive of this concept.

Thus far, one bill has been introduced on this issue: **HB-6139**.
