Here's How It Works:

- Only members Current on their Avon Chamber Dues are Eligible to Participate in This Program.
- Either a Current Member's Name or the Name of Their Business MUST Appear on the Sponsor Line of the Qualifying New Member Application in Order for the Member to Be Credited.

- Year for the Free Featured Listing or Free Internal Page Ad is Twelve Months from the First Day the Listing or Ad Goes Live on the Chamber Website.
- Any Subsequent Changes to the Qualifying Member's Online Directory Listing -- Including But Not Limited to: Business Name, Address, Phone Number, Fax Number, Contact Name, Business Type – After Posting of the Member's Free Featured Listing or Free Internal Page Ad Shall Not Extend the Free Year Period.
- Following the Free Year Period, the Member Shall Be Invoiced for and Have the Option of Either Continuing With the Ad They Received Via Receipt of Payment or Cancelling.
- Members Not Providing Requested Information for Completion of their Free Featured Listing or Free Internal Page Ad Within 30 Days of Being Notified of Qualifying for Such Shall Forfeit their Free Featured Listing or Free Internal Page Ad.
