Comcast/ACOC Advertising Program – Charmaine Seavy, CV Media, reviewed the program which offers members the opportunity to advertise on TV on "real" channels (i.e., major networks) during normal hours. ## Speaker: Sharon Gauthier, PAFY (Patient Advocate for You)

Sharon mentioned during her 30 second introduction that she had changed the name to PAFY because early on she found healthcare providers were intimidated when the words "patient advocate" were used. She is an RN and holds masters degrees in Public Health and Nursing. She is on the board of the Crohns & Colitis Foundation.

Sharon said she always wanted to be a nurse but the path was not straightforward. She married her husband at age 18 and dropped out of high school. She went to nursing school in her 40s. Once working, she learned that the only way to advance in salary was to work one's way up the ladder because otherwise pay raises were determined by time in the job.

She had a number of "ah ha" moments as she moved into management. Sharon told the story of having a relatively young woman with a family in the emergency room with a heart attack. At the time, the standard protocol was to give blood thinners to break up the clot. But the hospital she worked in had a catheterization lab where the patient's clot could be cleared. The lab, however, wasn't truly in operation 24 hours a day, and the cardiologist was at the beach. It would be 24 hours before he would arrive. In her judgment and that of the emergency room doctor, this woman would not last 24 hours without treatment with the blood thinners. But you were not supposed to give blood thinners if the patient was going to have cardiac catherization within 24 hours. She and the doctor were almost fired for going ahead and giving the patient the blood thinners to save her life.

She left management and moved into Case Management after realizing hospital leaders were focused on "revenue sources" rather than patients. Case management was all about length of stay at the time and not about what was best for the patient. She told the story of an 88-year old patient she kept for 2 extra days to assure he was connected to community resources when released. He had a wife with dementia. He did all of the driving, shopping, cooking.... He was going to be released with orders not to drive for 6 weeks.

She left case management after that with the idea of becoming an RN hired privately to be an advocate for her patients. Her mission was to empower people to get the right care. The RNs who work for her are all certified dementia practitioners with at least 20 years of experience. PAFY started a home care agency to handle their more complex cases, and Sharon said she uses Home Helpers as a great backup. (She can and does recommend other care givers.) They also started PAFY Family which takes a \$500 annual fee just to guarantee they will be there when you need them since most cases start with a crisis.

PAFY is starting to negotiate with accountable care providers because PAFY's patients don't end up going to the hospital.
